### Report of the Manager to the Unitholders

#### Introduction

E Fund RMB Fixed Income Fund is a sub-fund of E Fund Investment Fund Series. The inception day of the Fund was on 18 January 2012. The manager of the E Fund RMB Fixed Income Fund is E Fund Management (Hong Kong) Co., Ltd. and the trustee is Bank of Communications Trustee Limited.

#### **Fund Performance**

E Fund RMB Fixed Income Fund seeks to achieve long term capital growth in RMB terms through investment in a portfolio consisting primarily of RMB denominated and settled fixed income debt instruments issued or distributed within China which aim to generate a steady flow of income in addition to capital appreciation for the Sub-Fund. As of 30 June 2014, the Net Asset Value per unit of the RMB Fixed Income Fund for Class A and Class I was RMB104.88 and RMB106.19 respectively. The total size of the fund was approximately RMB0.76 billion.
